MEMORANDUM OF UNDERSTANDING

Associate in Nursing (CCSNH) and Bachelor of Science in Nursing (PSU)

BLOCK TRANSFER AGREEMENT

The Community College System of New Hampshire (CCSNH) and Plymouth State University (PSU) recognize the value of partnering to provide students seeking higher education with a variety of accessible pathways toward achieving their goals.

PSU will honor the credits earned from an Associate's Degree in Nursing at all CCSNH schools and apply them to PSU's Bachelor of Science in Nursing (*see detail below*). This program provides qualified students entry to PSU as a Junior from CCSNH in a supportive and transparent pathway that will strengthen accessibility to higher education. In all of its policies and procedures the program will aim toward simplicity, efficiency, and affordability for participating students. In order to qualify, students must earn an Associate's Degree in Nursing from a CCSNH school and successfully passed the National Council Licensure Exam (NCLEX).

It is recognized that this program continues the missions of CCSNH and PSU in recognition of the mutual benefit we bring to New Hampshire students and their families. As such, it is understood that the provisions of this agreement will continuously improve and evolve under the guidance and oversight of CCSNH/PSU.

CCSNH'S RESPONSIBILITIES:

1. A single application (with only one, if any, fee) completed from CCSNH.
2. Updates will be completed by Plymouth State's Assistant Director of Transfer Operations and the designated program coordinators at CCSNH and PSU.
3. CCSNH will promote this transfer agreement with all students earning an Associate of Science in Nursing.
4. Comprehensive academic advising to make sure students know the terms and conditions of the program and that they start and stay on track.
5. The program requires completion of an Associate degree in Nursing at CCSNH.
6. Sharing and exchange of information where appropriate with metrics to measure success.

PSU'S RESPONSIBILITIES:

1. PSU will promote this transfer agreement with all prospective students during recruitment travel who demonstrate interest in beginning their collegiate education at a community college.
2. Comprehensive academic advising to make sure students know the terms and conditions of the program and that they start and stay on track.
3. A communication plan to keep students informed on important matters from the point of inquiry through PSU enrollment.
4. Sharing and exchange of information where appropriate with metrics to measure success.

This Transfer Agreement will officially begin Fall 2025 and will remain in effect until a written notification is sent from either party to the other party. At the time the written notification is sent, both institutions will indicate how students currently in the pipeline will be handled. This program will be available for entry immediately and will be available to students enrolled at CCSNH.

BLOCK TRANSFER COURSE DETAILS:

Having successfully completed an Associate degree in Nursing, block transfer students will complete the following PSU courses:

- PBH2000 Foundations of Public Health (4)
- NR4600 Leadership, Collaboration, & Quality Health Care Systems (3)
- NR2750 Pathophysiology (4)
- NR3150 Pharmacology (4)
- NR4020 Global Health & Population Based Health Care (3)
- NR4060 Research Process & EBP (3)
- NR4083 Capstone (3)
- Business Course (choose from list of approved courses) (3-4)
- Social Issues Course (choose from list of approved courses) (3-4)
- Electives (to be determined by official credit evaluation)

**Except for NR designated courses, eligible transfer courses must be earned from an accredited institution with a grade of C- or higher. A maximum of 90 credits may be applied for transfer credit.*


